### Eagle Criteria

- ✓ Are they innovators and precedent-setters that influence peer companies or entities to do similar positive things for the disability community?
- ✓ Did they come up with a fix to accessibility issues without a lawsuit?
- ✓ Have they worked with the community to come up with a solution that is accessible to all?
  - ✓ Have they been compliant since a lawsuit?
  - ✓ Was there a positive settlement that resulted in a partnership with the community?
- ✓ Do they have people with disabilities on staff and in leadership positions?
- ✓ Do they have exemplary written disability, inclusion, and/or diversity policies?
- ✓ Do they get positive reviews from the disability community?
- ✓ Do they support disability-focused organizations?

### Turkey Criteria

- ✓ Have they failed to respond to a complaint or grievance filed against them?
- ✓ Have they been sued by DRA (or another similar entity) and failed to respond or address problems identified?
- ✓ Have they been sued by DRA (or another similar entity) and actively fought the lawsuit?
- ✓ Do they receive consistently poor reviews or get complaints from the disability community?
- ✓ Do they actively discriminate against people with disabilities?
